**ORDER**

Whereas, recognition was granted to the institution, Junior College of Education, Nandaon, Tal Nandgaon, Dist-Nashik-423106 for D.Ed course with an annual intake of 60 students vide order no. F.No.WRC/5-6/23/2000/8208-8217 dated 09.10.2000.

And whereas, the Institution vide letter dt. 11.12.2015 submitted an application for **shifting of premises** from Junior College of Education, Nandgaon, Tal.Nandgaon, Dist-Nashik-423106 Maharashtra to **Junior College of Education , Dindori, (M.V.P campus) Tal Dindori, Dist Nashik-422202 Maharashtra.**

And whereas, the matter was placed before WRC in its 282<sup>ND</sup> meeting held on October 24-26, 2017. The Committee decided to issue Conveying Decision letter. Accordingly, Conveying letter was issued on 07.11.2017 and the institution submitted reply of Decision on 04.12.2017.

And whereas, the matter was placed before WRC in its 285<sup>th</sup> meeting held on December 19-21, 2017, The Committee decided that VT be constituted.

And whereas, the inspection of the institution was conducted on 26.02.2018.


And whereas, the matter was placed before the WRC in its 290<sup>th</sup> meeting held on March 21-23, 2018. The Committee decided as under:-.

"...The case file was seen. This is a case of shifting. VT report was perused and the CD was seen. The CD shows a building with adequate infrastructural and instructional facilities. The VT has recommended the case.

**Hence, shifting is permitted."**

Now therefore, in exercise of the powers vested under section 14(3)(a) of NCTE Act, 1993, permission under clause 8(9) of NCTE Regulation, 2014, is hereby granted for change of premises from Junior College of Education, Nandgaon, Tal.Nandgaon, Dist-Nashik-423106 Maharashtra to **Junior College of Education , Dindori, (M.V.P campus) Tal Dindori, Dist Nashik-422202 Maharashtra,** with immediate effect for conducting D.Ed. course of two years duration with an annual intake of 60 students. **The institution has move towards a composite institution gradually, as per provision of NCTE Regulations, 2014.**
